
Name of Scheme : 2nd revised estimate for Investigation of Jiadhhal Dam Project

Chargeable Head : "River Basin Management- 3. Survey, Investigation & Preparation of DPRs of Multipurpose Projects including Mini-Micro Projects"


2. Terms & Conditions:

- i. Expenditure should not be incurred before detailed plan and estimates are technically sanctioned by the Competent Authority
  - ii. The expenditure should be limited to the budget provision
  - iii. Works are to be carried out as per approved Action Plan and release of fund will be regulated as per physical achievement
  - iv. Utmost economy to be observed during investigation & DPR preparation
  - v. Provision for Work-Charged pay and Works should be shown separately in expenditure statement
  - vi. No new recruitment of W/C staff shall be made and the existing W/C staff shall be utilized / re-deployed for the same
  - vii. Survey and Investigation works should be completed within the stipulated time
  - viii. This is in supersession to the earlier Administrative Approval accorded vide No: No.BB/9082/04/27 dated June 21, 2011.
