**Sub: - Administrative Approval of Scheme**

Administrative Approval of the following estimate is conveyed based on the approval of the 56<sup>th</sup> Meeting of the Standing Committee, Brahmaputra Board held on 18.07.2016 at Guwahati and ratification of the same in the 61<sup>th</sup> (adjourned) Meeting of the Brahmaputra Board held on 22.08.2016 at Guwahati with the terms and conditions as stated below-

**Name of Scheme:** Revised estimate for updating of Master Plan of 3(three) south flowing rivers i.e. Teesta, Jaldhaka and Torsa-Raidak of Brahmaputra Basin in North Bengal & Sikkim (2007-2019) (2011-12 to 2017-18)

**Estimated Amount:** Rs. 192.42 Lakh (Rupees one crore ninety two lakh forty two thousand) only

**Chargeable Head:** River Basin Management -Survey & Investigation and Preparation / Up-dating of Master Plan

**Terms & Conditions:**

1. Expenditure should not be incurred before detailed plan (as applicable) and estimates are technically sanctioned by the Competent Authority
2. The expenditure should be limited to the budget provision
3. Works are to be carried out as per approved Action Plan and release of fund will be regulated as per physical achievement
4. Utmost economy to be observed during the implementation of the work
5. Expenditure for Work-Charged pay and Works should be shown separately
6. No new recruitment of W/C staff shall be made and the existing W/C staff shall be utilized/re-deployed for the same
7. Deployment of contractual labours should be minimised by substituting the same with WC staff as far as possible
8. The competent authority is authorized to accord technical sanction to split the amounts into components and delegate the powers to subordinate officers to sanction individual components as per their respective powers.
9. Survey and Investigation works should be completed within the stipulated time.
10. Effort should be made to complete the Master Plan by December 2016.
