

2. Expenditure should not be incurred before detailed plan and estimates are technically sanctioned by the Competent Authority
3. The expenditure should be limited to the budget provision
4. Works are to be carried out as per approved Action Plan & release of fund will be regulated as per physical achievement
5. Utmost economy to be observed during the execution of the work

6. No new recruitment of W/C staff shall be made and the existing W/C staff shall be utilized/re-deployed for the same. Also, no new Special T&P should be procured and the available T&P should be used as far as possible
7. Works should be completed within the stipulated time
8. All works to be implemented in conformity of GFRs / Codal Procedures / CVC Guidelines etc
9. This is in supersession to the earlier Administrative Approval accorded vide No. BB/9045/Vol-IX/10/9 dated February 3, 2011
