N O T I F I C A T I O N .

In exercise of powers conferred under Sub-Section (8) & (9) under Section 4 of the Brahmaputra Board Act, 1980 and as per decision taken in the 11th meeting of the Brahmaputra Board held on 15.9.88, The Brahmaputra Board is pleased to constitute a Standing Committee consisting of the following members :-

1. The Vice-Chairman, Brahmaputra Board - Chairman.
2. The Member (RM), C.W.C. - Member.
3. The General Manager, Brahmaputra Board - Member.
4. The Secretary to the Govt. of Assam, F.C. Department. - Member.
5. The Financial Adviser, Brahmaputra Board - Member.

2. Convenor :-

The General Manager, Brahmaputra Board shall be convenor of the Standing Committee. He may co-opt a representative from any other concerned Central Govt. Deptt./State Govt. Deptt. or such other organisation/Agencies as may be necessary.

3. Duties & functions :

The duties and functions of the committee shall be as follows :-

1. To accord administrative approval to estimates upto Rs. 1.00 crore.
2. To accord approval for incurring expenditure by the Board officials beyond the powers delegated to them under the Delegation of Power Rules from time to time.
3. To accord approval to such other administrative matters which are required to be implemented by the Board urgently.

4. To advise the Board on the various investigations and studies to be taken up for preparation of the Master Plan and on multipurpose projects identified in the Master Plan including their execution. It will also give time frame for such studies/investigations/works as may be referred to it.
5. The Committee will suggest norms for preparation of estimates. It will also recommend for approval of estimates beyond the powers delegated to the Standing Committee.
6. Decisions/approval of the Standing Committee shall be placed before the Board in its immediate next meeting for ratification.


