Terms of Reference:

1. The team shall identify river basins for preparation of detailed Master Plans, other than those already taken up by Brahmaputra Board. The team shall fix up the priorities for the Master Plans to be taken up and recommend the time schedule for each.
2. The team shall finalize the frame-work of the Master Plans to be prepared on holistic approach covering assessment, development and management of surface and ground water system for overall development of the selected basins. The team shall identify the unique problems, specific to the basins so that the same are duly addressed in the Master Plans.
3. The Master Plans already prepared by Brahmaputra Board and approved by the Central Government covering the state of Meghalaya shall be reviewed by the Team. The Team shall give recommendations about the revisions/modifications to be made in these Master Plans.
4. The team may invite any officer from Central/State Government as special invitees on need basis.
5. The team shall meet as and when required and make site visits if needed. The team shall submit its inception report within 5 (five) months.

6. Chief Engineer, Water Resources Deptt., Meghalaya will make necessary arrangements to provide facilities during visits of the team to different places within Meghalaya as well as field investigations.
7. TA/DA in respect of the Members of the team will be borne by their respective Ministries/ Departments.


