**VACANCY CIRCULAR**

Applications are invited for filling up the following posts on deputation basis, in the Brahmaputra Board, Guwahati-29 a Statutory body established under an act of Parliament called Brahmaputra Board Act (46 of 1980) from candidates fulfilling the eligibility criteria as indicated against the posts:-
