- (viii) No fee is required to be paid by candidates belonging to SC/ST/PH/Ex-Servicemen categories, hence, the steps for payment of fees will not be applicable to them online application form. Once the fee is deposited the same shall not be refunded under any circumstances.
- (ix) The candidates should take a printout of the online application, affix a recent passport size photograph and preserve it with them for their record and should not send the same at NVS or any other address. The application printout with photograph affixed will have to be submitted during document verification along with the self-attested copies of certificates in support of Age, Qualification, Experience, Caste Validity, Non Creamy Layer, Physical disability, Valid identity proof as applicable.

  - Incomplete On-line application, in any manner shall be rejected and no further correspondence shall be entertained. In addition, no other means/mode of submission of application shall be accepted under any circumstances.

The list of short listed candidates for recruitment to the post of Audit Assistant, Hindi Translator, Stenographer, Catering Assistant, Staff Nurse, Lower Division Clerk/ Storekeeper, Lab Attendant will also be displayed on the NVS website.   - Canvassing in any form will disqualify a candidate.
