The sealed bid will be received in the office of the undersigned up to **15:00 hours of 25.4.2017** and will be opened on **the same day at 15:30 hours** in presence of the bidder or their authorized agent. The bidder has to deposit bid security amounting to **Rs. 2,000.00 (Rupees two thousand) only in the form of Deposit** at Call / Demand Draft **drawn from any Schedule Bank guaranteed by Reserve Bank of India** payable at Guwahati in favour of the **Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29** along with their bid.

DETAILED TERMS & CONDITIONS OF THE AUCTION

1. Bid Security Money: The Bid shall be submitted in sealed cover along with Security money amounting to **Rs. 2,000.00 (Rupees two thousand) only in the form of Deposit** at Call / Demand Draft **drawn from any Schedule Bank guaranteed by Reserve Bank of India** payable at Guwahati in favour of the **Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29**. The Bid security money of the successful bidder will be retained till completion of bid process. The Bid Security money of the unsuccessful bidder will be returned immediately after finalization of the bid.

2. Disposal of Vehicles: The detail of condemned Vehicles to be disposed-off by auction is shown as per enclosed list at Annexure-I.

3. Quoted Rate: The rate shall be quoted in Rupees in Schedule-I as a whole for 5 (five) Vehicles listed in Annexure-I.

The rate should be quoted both in figure and words, overwriting should be avoided, corrections made if any shall be duly initialed by the bidder. ***The bid offering the highest rate would only be considered for acceptance.***

4. Submission of Bid: The complete bid document along with Bid security amount as per terms and condition stipulated in bid document should be **submitted in a sealed cover and to be dropped in the tender box kept in the office of the Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29** on or before the scheduled date and time. The sealed envelope containing complete Bid Document is to be addressed **to the Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29**. All pages of the bid document should be duly signed by the bidder.

4. Opening of Bid: The bid will be opened on the Scheduled date, time and place as mentioned in the Notice. If the Schedule date becomes a Govt. holiday then the bid will be opened on the next working day. The interested bidder or their authorized agent / representative may remain present at the time of opening of the bid.

5. Rejection and Acceptance of Bid: The officer inviting Bid shall have the right of rejecting all or any of the Bids without assigning any reason thereof. Bidders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. Bids submitted not as per terms and conditions or contain too much error / corrections and / or absurd rates are also liable for rejection without assigning any reason.

6. Inspection of condemned Vehicles and assessment: Before submission of Bid, the bidder may inspect all the condemned Vehicles kept at Headquarters Complex of Brahmaputra Board, Basistha, Guwahati-29 to fully acquaint him / themselves about the condition of the condemned Vehicles. No claim whatsoever on such account shall be entertained by the Department under any circumstances later on.

7. Deposit of Bid value: The Successful bidder has to deposit the balance amount of bid money in addition to the security money already deposited within 3 (three) days from the date of confirmed order in the form of Bank Draft drawn from any schedule Bank guaranteed by Reserve Bank of India payable at Guwahati in favour of the Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-781029. The bidder has to lift / take away the condemned Vehicles from the Headquarters Complex of Brahmaputra Board, Basistha, Guwahati-29 immediately at their own cost after depositing the total value of bid amount. This office will not be responsible for any loss or damages of condemned Vehicles if the Vehicles are not taken away by the bidder immediately.

8. Essential Criteria for Bidder : The bidder must be an Indian citizen. Documents in support of identity and address are to be furnished along with the bid document.
