## DETAILED TERMS & CONDITIONS OF THE AUCTION

1. **Bid Security Money:** The bid shall be submitted in sealed cover along with security money amounting to Rs. 2,000.00 (Rupees two thousand) only for each group in the form of Deposit at call / Demand Draft drawn from any schedule Bank guaranteed by Reserve Bank of India payable at Guwahati in favour of the Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29. The Bid Security money of the successful bidder will be retained till completion of bid process. The Bid Security money of the unsuccessful bidder will be returned immediately after finalization of the bid.
2. **Disposal of materials:** The detailed of Condemned vehicles to be disposed by auction are shown as per enclosed list at Schedule for quoting rate for Condemned vehicle.
3. **Quoted Rate:** The rate shall be quoted in Rupees (Rs.) per unit as per Schedule for quoting rate for Condemned vehicle.
4. **Submission of Bid:** The complete bid document along with bid security amount as per the terms & conditions stipulated in bid document should be submitted in a sealed cover and to be dropped in the tender box kept in the office of the Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29 on or before the scheduled date and time. The sealed envelope containing complete Bid document is to be addressed to the Executive Engineer, Guwahati Division, Brahmaputra Board, Basistha, Guwahati-29. All pages of the bid document should be duly signed by the bidder.
5. **Opening of Bid:** The bid will be opened on the scheduled date, time and place as mentioned in the Auction Notice. If the schedule date becomes a Government holiday then the bid will be opened on the next working day. The interest bidder or their authorized agent / representative may remain present at the time of opening of the bid.
6. **Rejection and Acceptance of Bid:** The officer inviting Bid shall have the right of rejection all or any of the Bids without assigning any reason thereof. Bidders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. Bids submitted not as per term and conditions or contain too much error / corrections and / or absurd rates are also liable for rejection without assigning any reason.
7. **Inspection of Condemned vehicles and assessment:** Before submission of Bid, the bidder may inspect the Condemned vehicles stored at HQ Complex of Brahmaputra Board, Basistha, Guwahati-29 to fully acquaint him / themselves about the condition of the Condemned vehicles. No claim whatsoever on such account shall be entertained by the Department under any circumstance later on.
8. **Deposit of Bid value:** The successful bidder has to deposit the bid money within 7(seven) days from the date of confirmed order in the form of Bank draft drawn from any schedule Bank guaranteed by Reserve Bank of India payable at Guwahati in favour of the Executive Engineer, Guwahati Division, Brahmaputra Board, Guwahati-29.
