

## Brief notes about flood control measures/efforts being taken by the Brahmaputra Board for flood situation in North East

Brahmaputra Board has prepared 62 Master Plan, out of which 49 approved by Government of India. The approved Master Plans have been handed over to concerned state Governments of North Eastern states for implementation. After successful implementation of the recommendations of the Master Plans, the flood situation and erosion problem of the North Eastern states will be reduced greatly.

2. The Ministry of Water Resources, River Development & Ganga Rejuvenation, Government of India entrusted the following flood control measures/efforts to Brahmaputra Board are as under:
