Sub: Request for release of funds under "Integrated flood and River Bank Erosion Management Works at Rohmorja (Assam).

Dear Madam,

The release of fund in spite of clearance by the Technical Advisory Committee have not been effected and the same pending with The Neeti Ayog since long. The non release fund and the present devastating flood has aggravated the situation and the erosion is at its peak and the erosion has caused engulfing of residential areas and agriculture lands with crops standing there on. It is apprehended that if immediate steps are not taken to check the worst position the same will result in the position as happened in the past as mentioned below:

1. Thirty eight revenue villagers have been engulfed by mighty Brahmaputra River.
2. Half of Dibru- Saikhowa National Park and one sericulture farm have met with the same fate.
3. Four large tea gardens, more than fifty small tea growers plantation and numbers of schools have also been engulfed besides twenty thousand people have been displaced.
4. Then erosion is threatening Dibrugarh (Mohanbari) Air Port, Army Cantonment Area along with many more tea gardens and villagers.
5. The frustrated and angry local public has stopped drilling operation of three wells which is causing being massive one was beyond its control.

I would like to draw your kind attention and request you to kindly take up the matter for your kind perusal and take adequate measures to address the concerns of the public and the needful in this regards.
