

ORDER

In continuation of this Ministry's Order of even number, dated 10.01.2019, vide which revised cadre structure of Brahmaputra Board was conveyed, a detailed organogram up to Group-A level posts in the Board is enclosed for implementation. In respect of Group-B & C level posts, Chairman, Brahmaputra Board will issue separate organograms.

2. In the restructured Brahmaputra Board, offices of the Board will be opened in all North-Eastern States, Sikkim and West Bengal. Chairman, Brahmaputra Board is hereby advised to take appropriate action to implement the new structure, immediately and submit an Action Taken Report within two months from the date of issue of this Order, to the Ministry.


3. In the revised cadre structure of Brahmaputra Board, new incumbents are required to be appointed on direct recruitment basis. The Board is hereby advised to consider engaging an appropriate Central Government organisation for filling up these posts immediately. The Board is also advised to create a "Restructuring Cell" in the Headquarter for processing of cases of direct recruitment, promotion and other related establishment works, headed by the Secretary, Brahmaputra Board. Keeping in view the fact that there are no officers available in the Board with the knowledge and skill of establishment and administration, the aforesaid Cell may be established by engaging services of retired Government officers with sufficient knowledge of establishment and administration, immediately, on contract basis. The "Restructuring Cell" may be created for a limited period and will be wound up as soon as its purpose is achieved.

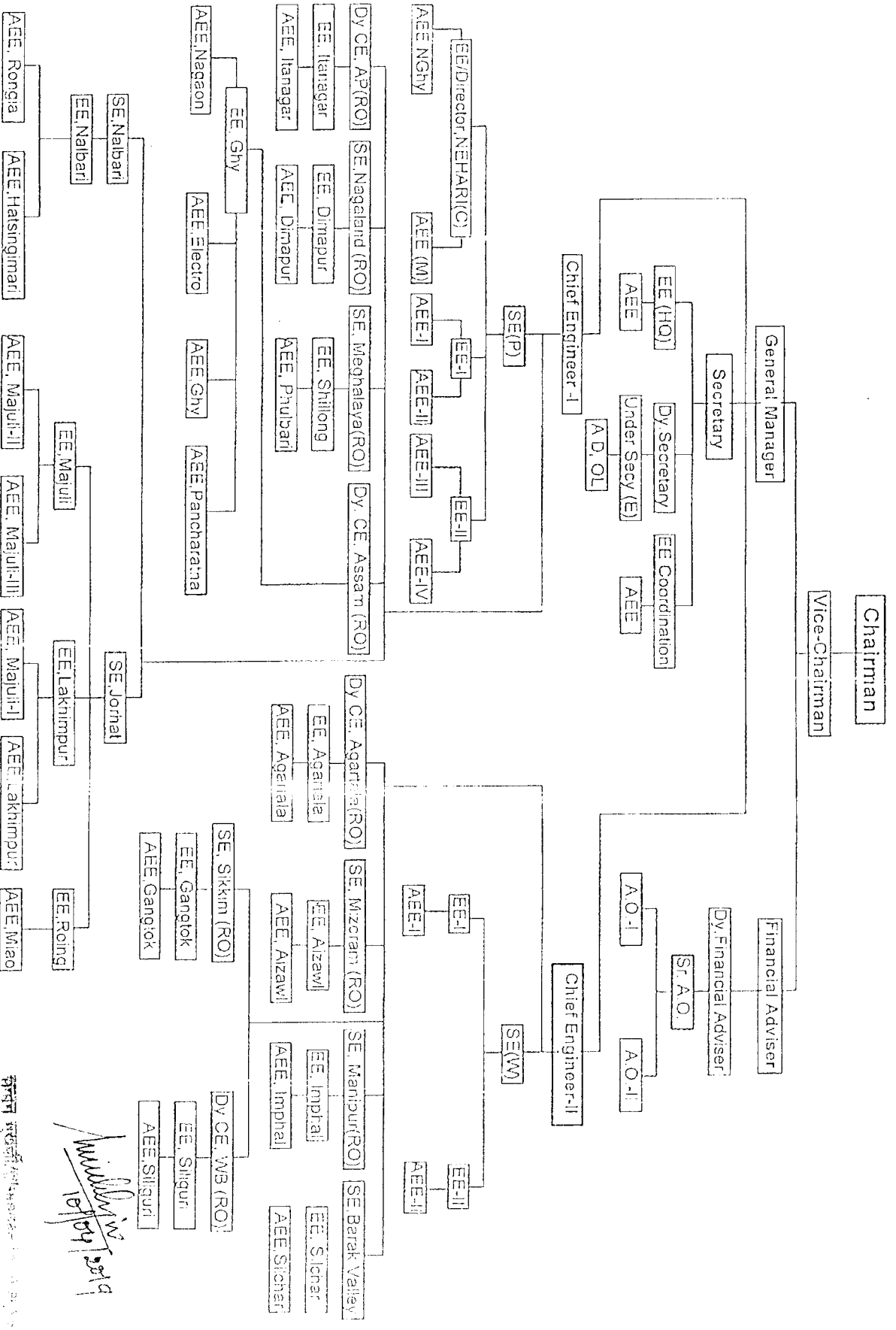
