**OFFICE ORDER**

As per Hon'ble CAT, Guwahati Bench's Order dated 27.11.2017 on O.A. No. 040/00052/ 21016 and as per approval of the Ministry of Water Resources, RD & GR vide No. C-18017/4/2016-E-III (BBE)/170 dated 24.07.2018, the following JEs are allowed to draw the 2<sup>nd</sup> stage financial up gradation under ACP scheme in the scale of 15,600/- 34,100/- in the PB-3 of Grade Pay of Rs. 5,400/- and 3<sup>rd</sup> stage financial up-gradation under MACP Scheme in the Pay Band PB-3, Rs.15,600/- 39,100/- + GP Rs.6,600/- with effect from the date of their eligibility.

This supersedes all previous office orders granting 2<sup>nd</sup> ACP and 3<sup>rd</sup> MACP benefits to the said Junior Engineers.



The grant of financial upgradation is subject to the provisions of the DoPT O.M. No.35034/3/2008-Estt (D) dated 19.05.2009 including the following-

1. The above financial upgradation merely envisages placement on personal basis in higher pay scales and will not amount to actual/ functional promotion.

2. The designation of the incumbents will not change due to financial upgradation.
3. The financial upgradation shall not confer any privilege related to the higher status.
4. Grant of higher pay scale under MACP scheme is conditional to the effect that the incumbent while accepting the said benefit shall be deemed to have given his/ her unqualified acceptance for the vacancy based promotion to the higher pay scale which may occur subsequently and in case of refusal, he/ she shall be debarred from promotion as per rules.
5. On upgradation under MACP scheme, the beneficiary is entitled to have his/her pay fixed in accordance to the MACP guidelines issued from time to time.
