The bidder should produce original copies of up to date Income Tax clearance Certificate/ PAN card / VAT registration certificate / VAT clearance Certificate at the time of procurement of quotation Document.
- Earnest Money:** The quotation shall be submitted in sealed cover along with Earnest money as stated above for each group in the form of (i) FDR or (ii) Demand draft or (iii) Deposit at Call Receipt drawn from any schedule Bank guaranteed by Reserve Bank of India payable at Guwahati in favour of the Executive Engineer, Guwahati Division, Brahmaputra Board, Basistha, Guwahati-29. The earnest money of the successful bidder will be retained and will form a part of the security deposit till completion of the work. The earnest money of the unsuccessful bidder will be return after finalization of the bid.
