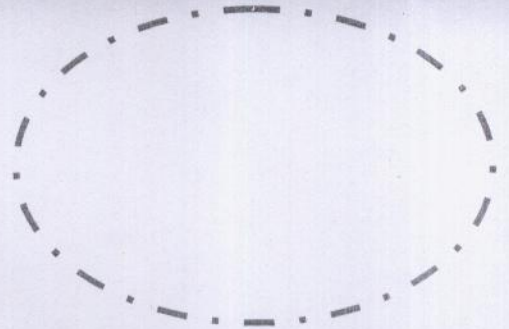

NAME OF WORK: : REPAIRING THE 20 H.P ELECTRICAL OPERATED PUMP SET AT NEHARI.

All rates in the Tender/ Quotation paper shall be clearly written both in figures and in words. In case there is any confusion, the rate quoted in words shall only be considered.

1. If the rates as mentioned in figure and in words do not tally for any item, the tender/ quotation shall be readily cancelled at any point of time.
2. The Tenderer/ Quotationer shall sign all pages of the Tender / Quotation document and shall properly seal the documents in envelop prior to submission of the same.
3. Rates shall include all costs of materials, labours, taxes, Levis, duties, octroi, VAT etc. The taxes as applicable shall be deducted at source.
4. The attested copies of Latest PAN Card / TIN / Up to date VAT clearance Certificate / Registration of the Firm etc. shall have to be invariably attested and enclosed with the sealed Tender/ Quotation failing which the Tender/ Quotation may be liable to be rejected at any point of time.
5. The Tenderer/ Quotationer must ensure clear and legible writing in the Tender/ Quotation paper. In case of any correction or over writing, the same shall have to be duly signed by the Tenderer/ Quotationer. Otherwise, the tender/ quotation may be liable to be rejected at any point of time.
6. The rates shall be valid for at least 1 (one) year.
7. On acceptance of the tender/ quotation by the competent authority, the agreement (as and where necessary as per current norms) shall have to be executed on the relevant CPWD Agreement Form.
8. The Brahmaputra Board Authority reserves the right to accept or reject any or all tender(s) / quotation(s) without assigning any reason thereof.
9. The Brahmaputra Board Authority reserves the right to split the work/supply (if the authority deems so) if necessary.
10. The time allowed for completion of each supply/ work: As mentioned in the NIT/NIQ.
11. No tender/ quotation shall be accepted after the due date and time.
12. The authority of Brahmaputra Board shall not be responsible in any manner for delay or loss or non receipt of the application for issue of tender / quotation paper and nor shall they be responsible in any way for late submission of the same by the tenderer/ quotationer because of any postal delay or otherwise.
