Sealed quotations are invited from reputed firms, transporters and bidders based at Delhi for hiring of vehicle by Brahmaputra Board. The Quotation as per **Annexure-I** should be accompanied with earnest money of Rs.5,000.00(rupees five thousand) only in the form of call deposit/ Banker cheque/ demand draft etc. from any Nationalized bank drawn in favour of the Financial Adviser, Brahmaputra Board, Basistha, Guwahati-29. Detailed specification of items, terms and conditions etc. may be obtained from the undersigned on payment of Rs.500.00 (Rupees five hundred) only as cost of quotation papers in the form of IPO duly pledged to the Financial Adviser, Brahmaputra Board, during the office hour from 11.00 am to 15.00 hours on all working days from 16.11.2020 to 26.11.2020.

1. Eligibility criteria for firms, contractors etc. will be ascertained after verification of latest GST Registration Certificate, Trade license and PAN Card etc.
2. The quotation must be accompanied by earnest Money in the form of call deposit/Bank draft for Rs.5000.00(rupees five thousand) only drawn on any Nationalized Bank in favour of Financial Adviser, Brahmaputra Board, Basistha, Guwahati-29.
3. Details of quotation are also available on the Brahmaputra Board website www.brahmaputraboard.gov.in and Notice Board of Coordination Office, Brahmaputra Board, New Delhi.
4. Intending bidder(s) have to produce a certificate regarding having own/leased at least 10(ten) numbers of vehicles of various model(2018 make or nearer) like Canter with valid license for providing vehicles on hire to Government Departments, Public Sector Undertakings, Autonomous Organisations, Company etc.

5. The bidders have to prove their eligibility and submit necessary documents and deposit the cost of quotation papers in the form of I.P.O. of Rs.500.00(Rupees five hundred) only. In case quotation paper downloaded from web site, the cost of tender document as mentioned above should be submitted at the time of submission of tender documents. Otherwise, their quotations will not be taken into consideration. Firms located outside Delhi should have local branch office at Delhi.
